

## 2024 TJX Rewards® iHeartRadio Jingle Ball Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** The 2024 TJX Rewards® iHeartRadio Jingle Ball Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico who are at least eighteen (18) years old at the time of entry and who are TJX Rewards® credit card holders as of October 31, 2024. Employees of The TJX Companies, Inc., Merkle Inc., Synchrony Bank and their affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. During registration, follow the instructions to select one (1) iHeartRadio Jingle Ball concert location (each a “Concert Prize Pool”) from the provided list that you would most like to win. You will receive one (1) Sweepstakes entry into the selected Concert Prize Pool drawing. You will only have the option to select a Concert Prize Pool one time and may not change your selection during the Promotion Period. iHeartRadio Jingle Ball concert locations and dates are listed below:

At checkout, you must use your TJX Rewards® credit card as the form of payment to receive one (1) Sweepstakes entry into the selected Concert Prize Pool drawing. See entry limit below.
- b.
