

# Lucky 25 Monthly Member 2026 Sweeps

## **Eligibility:**

Lucky 25 Monthly Member 2026 Sweeps (the "Sweepstakes") is open only to legal residents of the 50 United States, the District of Columbia, and Puerto Rico who are at least 18 years old at the time of entry. Employees of The TJX Companies, Inc. ("Sponsor"), Merkle Inc. ("Administrator"), Synchrony Bank, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

## **Agreement to Official Rules; Entrants Will Be Disqualified for Violations:**

Participation constitutes each entrant's full and unconditional agreement to these official rules ("Official Rules"). ## **How to Enter:**

During the Promotion Period, there are 2 ways to enter the Sweepstakes as outlined below:

### **Method 1 – Make a Purchase using your TJX Rewards® credit card (in Store or online)**

#### **Entry Requirements and Limits for an In-Store Purchase:**

Visit a T.J.Maxx, Marshalls, HomeGoods, Sierra, or Homesense store (each a "Store") and make a purchase using your TJX Rewards® credit card. You will automatically receive 1 Sweepstakes

entry into the applicable Monthly Entry Period drawing associated with the date and time of the purchase transaction as determined by Synchrony Bank (the TJX Rewards credit card processor). Your entry will not be included in any subsequent Monthly Entry Period drawings.

Limit: 1 entry per Store per calendar day.

**Entry Requirements and Limits for an Online Purchase:**

Make an online purchase from any of the following websites: [TJMaxx](#), [Marshalls](#), and [Sierra](#). Use your TJX Rewards® credit card to complete the purchase. You will automatically receive 1 entry into the applicable Monthly Entry Period drawing associated with the date and time of the purchase transaction as determined by Synchrony Bank (the TJX Rewards credit card processor). Your entry will not be included in any subsequent Monthly Entry Period drawings.

Limit: 1 Online Purchase entry per calendar day.

**Opt out of the Sweepstakes if you have made a in-store or online purchase with your TJX Rewards credit card and you don't want to participate:**

To opt-out of the Sweepstakes, visit the [Opt-Out](#) landing page. Submit the email address associated with your TJX Rewards® credit card. By taking this action, all of the qualifying TJX Rewards credit card purchases you have made and those that you make in the future (through December 31, 2026) will not be included in any Monthly drawing for this Sweepstakes after the date of your opt-out request. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**Method 2 – Enter by Mail:**

To enter without use of the TJX Rewards® credit card or purchase, print your name, address, phone number, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Lucky 25 Monthly Member 2026 Sweeps,” c/o Merkle Inc., P.O. Box 5046, Department 840223, Kalamazoo, MI 49003-5046, U.S.A. **You must also list out the Monthly Entry Period for which you are entering on the outside of the envelope, (e.g., “Monthly Entry Period 1”).** You will receive 1 entry into the Sweepstakes. Limit: 1 entry per envelope and up to 20 entries per Monthly Entry Period. If you do not indicate a Monthly Entry Period on the outside of the envelope, your entry will be voided, and you will not receive entries into the Sweepstakes. All mail-in entries must be sent/postmarked by the dates listed in Timing Section above. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of

receipt by the Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

### **Entry Limits:**

Each entrant may receive up to 3 entries per day using the Purchase Methods, and up to 20 entries total per Monthly Entry Period regardless of method of entry or combination of methods of entry. Multiple entrants are not permitted to share the same email address. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information associated with entrant's TJX Rewards® credit card. If any additional information provided by entrant is inconsistent with the information provided at registration for this Sweepstakes the Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

### **Prize Drawings and Winner Requirements:**

Administrator is an independent organization whose decisions as to the selection of the winners are final and binding. Administrator will randomly select the Monthly Entry Period winners from all eligible entries received during the applicable Monthly Entry Period on or around the dates listed in the Timing Section. Selected winners will be notified by email with the digital prize code. If a winner cannot be contacted or the prize is returned as undeliverable, the winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a winner is disqualified for any reason or forfeits a prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only 3 alternate drawings will be held, after which the prize will remain unawarded.

### **Prizes:**

#### **Quantity, Description and Approximate Retail Value ("ARV"):**

**300 Grand Prizes** (25 will be awarded per Monthly Entry Period): Each winner will receive a \$100 TJX digital gift card fulfilled to winner's email address. Terms and conditions apply. ARV: \$100.

#### **Total ARV:**

The total ARV of all available prizes offered in the Sweepstakes is \$30,000.

#### **Odds of Winning:**

The odds of winning a prize depend on the total number of eligible entries received during each Monthly Entry Period.

**Additional Prize Terms:**

Prizes are non-transferable, and no substitution will be made except as provided in the Sponsor's sole discretion should the prize become unavailable. In this case, a prize of equal or greater value will be offered. Winners are responsible for all taxes and fees associated with prize receipt and/or use. ARVs are determined as of the time these Official Rules were published and the value of a prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. **Release:**

**Publicity:**

Sponsor is not obligated to use any of the above-mentioned information or content but may do so and may edit these materials at its sole discretion, without further obligation or compensation. Sponsor will not use any of the above mentioned information in a manner that is inconsistent with its Privacy Policy or applicable law.

## **General Conditions:**

### **Sponsor's Right to Modify or Cancel:**

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, including but not limited to fulfillment of the prize(s), where any of the following "Issues" occur:

- Fraud;
- Technical failures;
- Human error;
- Any other factor that impairs the integrity or proper functioning of the Sweepstakes; or
- Any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, widespread illnesses, declarations of war, acts of God, acts of terrorism) that interferes with any aspect of the Sweepstakes, as determined by Sponsor in its sole discretion.
- Where one or more of the above Issues occurs, Sponsor will make reasonable efforts to award all remaining Sweepstakes prizes by conducting a random drawing from among all eligible entries received up to the date of the Issue; and/or modify the prizes offered.

### **Sponsor's Right to Disqualify Entrants:**

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes, including but not limited to submitting fraudulent entries, or to be acting in violation of the Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

### **Sponsor's Right to Limit Prizes Awarded to the Number Stated in these Official Rules:**

In no event will more prizes than are stated in these Official Rules be awarded. ## **Limitations of the Scope of Responsibility:**

The Released Parties are not responsible for:

- Late, lost, undeliverable, damaged or stolen mail; delayed or misdirected entries or failure to receive entries due to limitation of third-party social network platforms;
- Entries that are erroneously deleted, lost or destroyed or corrupted. In this case, entrants sole remedy is to take the required actions to receive another entry(s) in the Sweepstakes, if it is possible; or
- Any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or to the receipt, use, inability to use or misuse of any prize.

## **Disputes:**

Except where prohibited, entrant agrees that:

- Any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually without resort to any form of class action and exclusively by the United States District Court for the Eastern District of Michigan or the appropriate Michigan State Court located in Oakland County, Michigan;
- Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and
- Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction) which would cause the application of the laws of any jurisdiction other than the State of Michigan.

If the application of any provision of these Official Rules to any particular facts or circumstances shall for any reason be held to be invalid, illegal or unenforceable by a court, arbitration panel or other tribunal of competent jurisdiction, then:

- The validity, legality and enforceability of such provision as applied to any other particular facts or circumstances and the other provisions of these Official Rules shall not in any way be affected or impaired thereby; and
- Such provision shall be enforced to the maximum extent possible.

In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it so as to be enforceable to the extent compatible with applicable law.
